Twenty-two colleges and universities earn national accreditation for concurrent enrollment programs

Partnerships with states drive program improvement at many institutions

The National Alliance of Concurrent Enrollment Partnerships (NACEP) announced today that 22 colleges and universities in Arkansas, Indiana, Iowa, Minnesota, and Utah have been granted national accreditation for their concurrent enrollment programs. NACEP accreditation validates the quality of college courses offered in high schools and ensures that the course content and student expectations match the standards of the sponsoring post-secondary institution.

"Iowa community colleges have had quality concurrent enrollment programs for a number of years, but preparing for NACEP accreditation has helped colleges demonstrate to the public that these offerings are of high quality," stated Jeremy Varner, Education Program Consultant at the Iowa Department of Education. "The NACEP process has helped concurrent enrollment programs obtain the institutional resources to better involve faculty and provide greater oversight of the programs. I am very pleased with the progress concurrent enrollment programs have made as they worked to obtain accredited status."

NACEP President Lynn Burbank remarked: "Through NACEP's rigorous accreditation peer-review process, each post-secondary institution has demonstrated that it integrates high quality standards-based practices across its concurrent enrollment program. We are pleased to award this prestigious recognition to these twenty-two institutions."

To earn accreditation from NACEP, concurrent enrollment programs conduct a self-study, document how their programs adhere to NACEP's 17 standards, and are evaluated by peer reviewers from NACEP-accredited programs. NACEP's standards were developed and refined over many years, serve as a model for quality standards in 15 states, and are adaptable to a wide range of higher education institutions.

"Historically NACEP-accredited programs have led the way in fostering statewide dialogue to promote effective practice," noted Karen Hynick, System Director for College Transitions for the Minnesota State Colleges and Universities (MnSCU). "NACEP's standards provide a framework to guide institutions in implementing a quality concurrent enrollment program. In particular, the curriculum standards require faculty site visits to high schools to ensure the concurrent course is indeed the same course offered on the college campus. Faculty standards speak to the importance of ongoing, discipline-specific professional development for concurrent enrollment instructors."

In all five states where programs were accredited in 2012, NACEP has worked for many years to improve the quality of concurrent enrollment courses offered by all higher education institutions, providing students an assurance that the courses they take are true college courses.

"NACEP accreditation demonstrates the commitment of North Arkansas College to academic rigor onand off-campus," said Gwen Gresham, Executive Vice President of Learning at North Arkansas College which sponsors one of the newly-accredited concurrent enrollment programs. "Northark's mission is to 'provide high quality, affordable, convenient opportunities for learning and community enrichment,' and NACEP accreditation reinforces every element of that mission."
