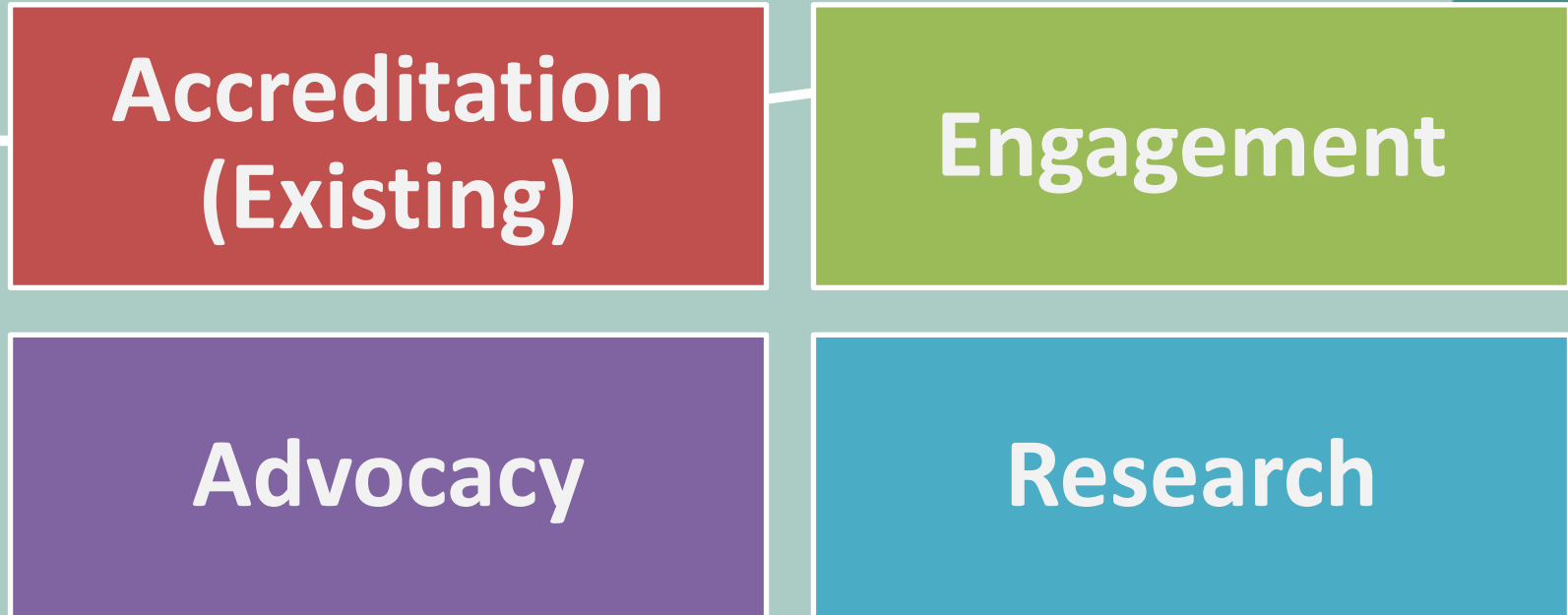

# Proposed Commission Structure



The three new commissions would include representatives from all membership categories:

- an Appointed Chair and Vice Chair
- Five Elected Representatives – voted on by all members
- One appointment each reserved specifically for Secondary and State Agency/Partner Organization members

# Proposed Commission Structure

## Accreditation (Existing)

- Manage the accreditation process
- Review reports prepared by Peer Review Teams
- Make accreditation decisions
- Establishing accreditation policies

## Engagement

- Recruit new members in support of the organization's goals
- Provide professional development and support to all members
- Serve as a conduit in collecting and sharing the successes and issues of members and other commissions

# Proposed Commission Structure

## Advocacy

- Facilitate NACEP interaction with federal and state governments and departments of education
- Develop & maintain a positive image for concurrent enrollment programs
- Strengthen communication with policy-making governmental agencies

## Research

- To conduct, support and share research on concurrent and dual enrollment
- To provide tools for programs in conducting program evaluations
