I Just Created a SAFE Account--Why OH|ID?

- The Innovate Ohio Platform provides integrated and scalable capabilities that enable state agencies to become more customer-centric and data-driven.
- Creates an integrated customer experience that brings higher quality services to the public.
- Ensures that state resources and information are accessible to every Ohioan
- Keeps information secure and private and simplifies interactions with state systems.

Create a New OH|ID Account

- Click the Login link at the top of the page
- Choose "OH|ID Portal"

Ohio District Data Exchange (ODDEX)

Who, what, and how to report data?

- Public secondary schools must submit student enrollment via EMIS
 - Must indicate the course is a college course
- Colleges/universities must submit enrollment data via CCP Portal
- Colleges and public secondary schools verify enrollment in ODDEX
 - Once enrollment review window closes and all enrollment verified, payment is generated

Ohio District Data Exchange (ODDEX)

Who, what, and how to report data?

- Public secondary schools – EMIS and ODDEX
 - Typically this is submitted by a school's EMIS Coordinator
 - Regular ODE training sessions throughout the year available on EMIS and ODDEX
 - Old presentations are archived on education.ohio.gov website (search EMIS or ODDEX)

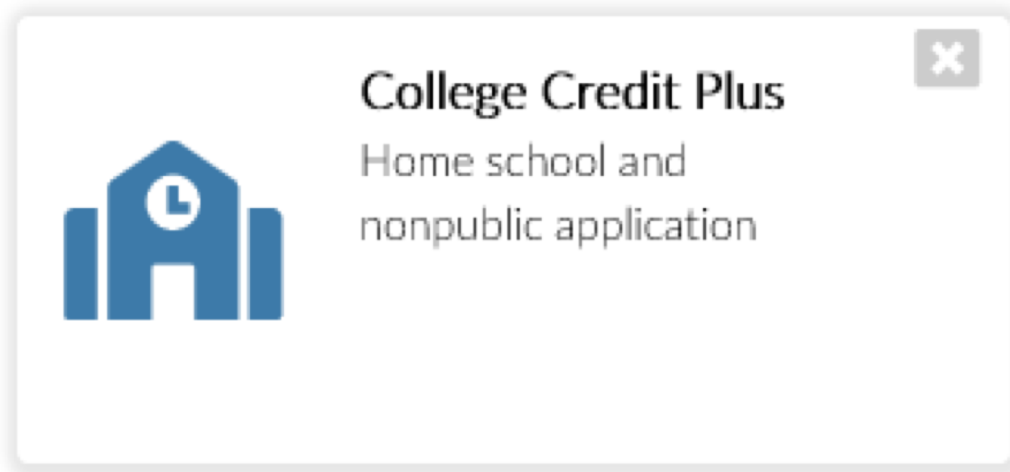
Who, what, and how to report data?

- Colleges/universities – CCP Data Portal and ODDEX
 - Responsible person might be CCP Coordinator/Director, Institutional Research, Registrar, Fiscal Officer, etc.
 - Annual training
 - September 17, 2019

Nonpublic and Homeschool Funding Application

- Parents must apply online through the OH|ID portal
 - Can apply for the OH|ID account at any time (encouraged to apply as early as possible!)
 - The intent to participate form is included in the funding application (no separate form needed)
 - Application window February 3-April 1, 2020
 - Note the application and intent letter deadline is the same
- Parent must click “Submitted” to submit the application



College Credit Plus Funding

Funding in General

- How does the funding work?
 - Public schools receive foundation funding
 - Based on FTE
 - Students choose their education paths—if College Credit Plus, then a portion of the foundation funding is redirected to the college
 - Nonpublic and Homeschool funding is determined by the General Assembly

Determining Costs

- Default rates or alternative funding agreements
- Alternative funding agreements between college and secondary schools Must be executed annually by February 1
- Default rates are set biennially by General Assembly
 - Ceiling – typical rate for online or at the college campus courses
 - Mid-Level – typical rate for at the high school with a college faculty member
 - Floor – Typical rate for at the high school with an approved high school teacher

Determining Costs

- Default rates for 2019–2020 – per credit hour

	Semesters	Quarters
Ceiling	\$166.55	\$111.04
Mid-level	\$83.28	\$55.52
Floor	\$41.64	\$27.76

- If college's standard tuition rate is less than the ceiling rate, the college will receive their standard tuition rate

Nonpublic and Homeschool Funding

- Determined by the General Assembly
 - Nonpublic \$2.6 million
 - Homeschool \$1.5 million

Nonpublic and Homeschool Funding

- Application must be submitted for each year of participation
- Maximum number of hours requested is 30
- Funds awarded on a grade-level rotation
- May not transfer funds between applications (homeschool and nonpublic)
