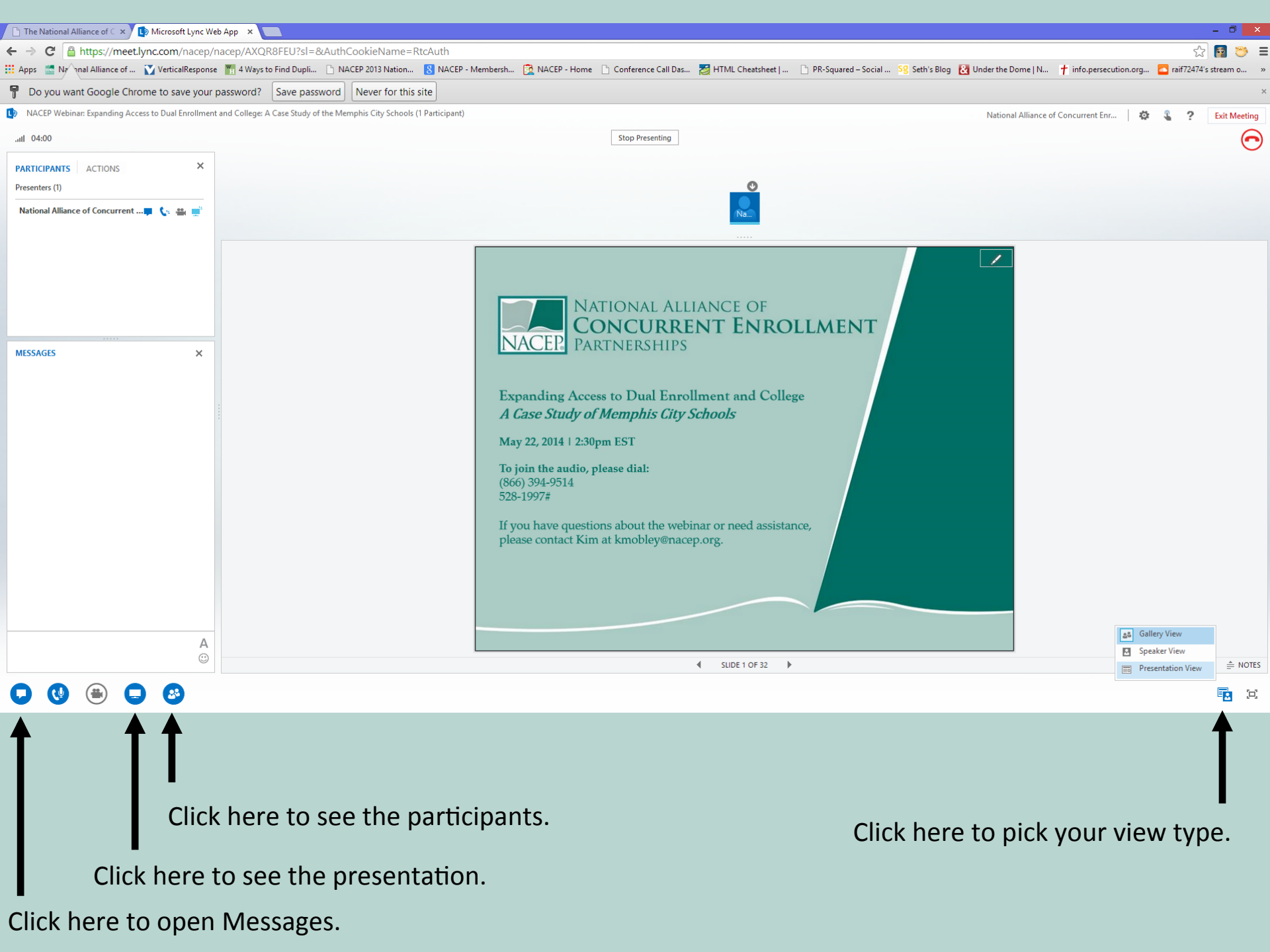

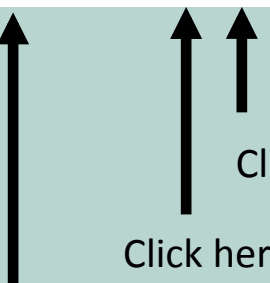

## ASSIGNED ROLE IN NACEP BYLAWS

### Strategic Goal #2

**Objective #2.** Build relationships with like-minded organizations and key decision-makers to advance NACEP's mission

**Action Step C.** Create opportunities for key state and federal decision-makers to learn about NACEP and standards-based concurrent enrollment through study tours, dialogues, model legislation or other methods.



# SETTING THE COMMITTEE'S PRIORITIES

## NACEP PLATFORM

1. Support language in Elementary Secondary Education Act (ESEA) to include Concurrent Enrollment programs as a viable form of access to college for all students.
2. Support Concurrent Enrollment programs ensuring that ALL students in good standing have equal access to engage in college classes providing academic rigor for a more meaningful high school experience.
3. Support access to federal appropriations funding for Concurrent Enrollment programs.

# SETTING THE COMMITTEE'S PRIORITIES

## NACEP PLATFORM (CONTINUED)

4. Support partner institutions in ongoing professional development of high school Concurrent Enrollment instructors in the continuous improvement process.
5. Support adherence to an accepted set of national standards that ensure quality Concurrent Enrollment programs.
6. Support ongoing, documented research and evaluation of students, faculty, schools, and colleges in Concurrent Enrollment programs to provide continuous program improvement and the most effective state and federal policies.
