Established in 1999 in response to the dramatic increase in concurrent enrollment courses throughout the country, NACEP serves as a national accrediting body and supports all members by providing standards, research, communication, and advocacy.



What is concurrent enrollment?

Concurrent enrollment partnerships (CEPs) are collaborations between high schools and colleges that allow qualified high school students to earn college credit by taking college courses taught in their high schools. Postsecondary institutions select and prepare outstanding high school instructors to teach the college courses. College faculty support CEP instructors by providing them continuous professional development. Students earn both high school and college credit for the CEP courses they take, thereby saving money on future college costs and gaining confidence that they can succeed as full-time college students.

NACEP standards ensure program quality.

Developed as the result of a three-year, nationwide discussion among CEP professionals, NACEP standards identify key elements of quality in the areas of curriculum, high school instructors, students, assessment, and program evaluation. Member institutions may be accredited as full NACEP members upon demonstrating that they meet or exceed the measurable criteria, which form the basis of the NACEP standards.
