Greetings NACEP Members,

I hope you have heard the exciting news that the Voting Membership approved the significant changes in the NACEP bylaws proposed by the NACEP Board of Directors. These changes, which become effective October 15, 2019, create and modify Board and Commission positions that are open to the membership by appointment and election. In the upcoming days you will be receiving an additional email regarding the opportunity to run for **Elected Commission Positions**. My email to you today is directed to those who are personally interested in nominating yourself or a colleague for an **Appointment**.

Previously, NACEP's formal volunteer leadership opportunities were only open to members from accredited program. The by-law changes open some NACEP Board positions and all NACEP Commission positions to all members, regardless of the accreditation status. There are 15 NACEP positions open by **Appointment** (see chart below). Terms of the Commission appointment are 2 years and begin on October 15, 2019. All appointments are made by the President subject to approval by the entire NACEP Board.

Each Commission serves an important role in advancing the organization. Commissions work on projects both developed internally assigned by NACEP. A summary of the function of each is provided below.

The Engagement Commission's main function is to:

- Recruit new members in support of the organization's goals.
- Provide professional development and support to all members.
- Serve as a conduit in collecting and sharing the successes and issues of members and other commissions.

The Advocacy Commission's main function is to:

- Facilitate NACEP interaction with federal and state governments and departments of education.
- Develop & maintain a positive image for concurrent enrollment programs.
- Strengthen communication with policy-making governmental agencies.

The Research Commission's main function is to:

- To conduct, support and share research on concurrent and dual enrollment.
- To provide tools for programs in conducting program evaluations.
- Curate resources (research, publications, summaries) on dual and concurrent enrollment research, policy, trends and best practices.

The NACEP Board of Directors positions open by appointment:

- Advocacy Commission Chair/ Board of Director member open to all members in good standing.
- Engagement Commission Chair/ Board of Directors member- open to all members in good standing.
- Research Commission Chair/ Board of Directors member open to all members in good standing.
- Treasurer/ Board of Directors member- open to members from accredited institutions.
- Secondary Member of Board of Directors open to all Secondary members in good standing.
- State Agency Member of Board of Directors open to all State Agency members in good standing.

The new Appointments to the NACEP Advocacy Commission that are open to all members are the following:

- Vice-Chair of Advocacy Commission open to all members in good standing.
- Secondary Member of the Advocacy Commission-open to Secondary members in good standing.
- State Agency Member of the Advocacy position open to State Agency members in good standing.

The new Appointments to the NACEP Engagement Commission that are open to all members are the following:

- Vice-Chair of Engagement Commission open to all members in good standing.
- Secondary Member of the Engagement Commission-open to Secondary members in good standing.
- State Agency Member of the Engagement position open to State Agency members in good standing.

The new Appointments to the NACEP Research Commission that are open to all members are the following:

- Vice-Chair of Research Commission open to all members in good standing.
- Secondary Member of the Research Commission-open to Secondary members in good standing.
- State Agency Member of the Research position- open to State Agency members in good standing
